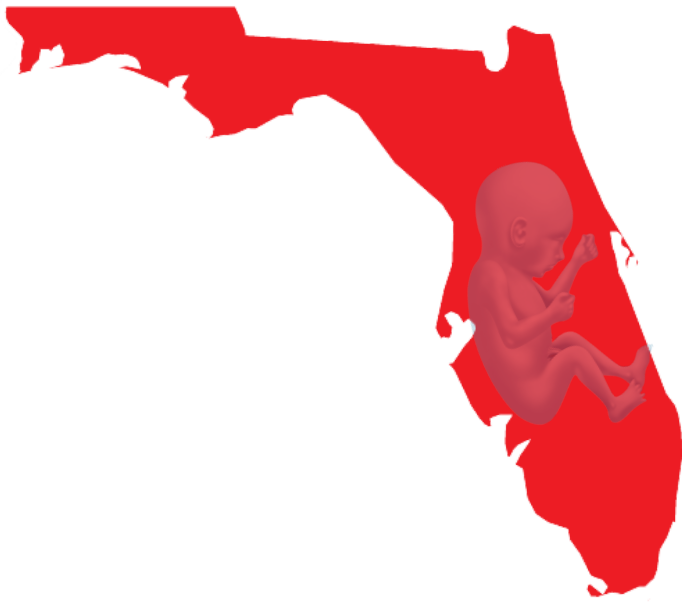


The Campaign to End Child-Killing in Florida

Some Facts

- Texas has 1/3 greater population than Florida and, even before the passage of its Heartbeat Bill, had 1/2 the abortion facilities.
- Ohio has 1/2 the population of Florida, but has only 1/7 the number of abortion facilities.
- In 2020, 74,868 abortions were performed in Florida of those 41,809 (56%) were chemical abortions.
- **Chemical abortions are on the rise in Florida.** The Chemical abortion pill is available via mail order, making do it yourself and at home abortions more prevalent. Aborted babies are often flushed into the wastewater system. Florida has state statutes governing the abortion industry in the disposal of such "medical waste" including during home care. Florida likewise reclaims wastewater for reuse. So our natural water resources and non potable water is potentially laden with the remains of chemically aborted babies! What about our swimming and bathing water? And our drinking water?

Questions

- Why would a conservative, red state have so many abortion facilities murdering such a great number preborn children?
- Are there obstacles in the Republican held State House of Representatives and State Senate?

WHAT YOU CAN DO

*Contact the **Speaker of the House, Chris Sprowls** (727-793-2810, chris.sprows@myfloridahouse.gov) and the **Senate President, Wilton Simpson** (352-688-5077, Simpson.wilton@flsenate.gov)

Inform them that has 58 abortion facilities killing almost 75,000 babies per year and this is an outrage. Ask them what their plans are to deal with this scandal. Are they committed to passing a heartbeat bill similar to Texas (if Roe vs Wade is not overturned) and a trigger abortion ban (in case the Supreme Court does overturn Roe vs Wade?)

Ask what her office has done and will do to ensure that abortion facilities and abortionists are obeying all Florida statutes. For instance, why is the abortion industry not being held accountable for violating Florida statutes on the disposal of medical waste? A violation that is now polluting Florida's water supply.

Do they follow-up on reports of women wounded or even killed by abortion? Medicaid fraud?
